Remedy

Pursuant to this limited warranty, within the warranty period TRC, in its sole discretion, will:

- Replace the unit or any defective parts with a functional equivalent; or
- Make a payment to the original purchaser of the unit in an amount equal to the cost of repair based on TRC's estimate and in its sole judgment.
- The 1st year of the warranty period covers parts replacement and labor. The 2nd or any following year of the warranty period covers parts replacement only, not labor, and includes a \$150 deductible in all cases other than Allison applications for school buses.

Limitations and Exclusions

- This limited warranty is applicable solely to the original purchaser and is not transferable.
- This limited warranty is expressly conditioned upon the covered unit or units having been properly installed on vehicles approved by the O.E.M. for such purpose and being used for on-highway or off-highway vehicles in the United States.
- Units installed as replacements under this warranty are warranted only for the remainder of the original warranty period.
- This warranty is not applicable to units for which the original invoice remains outstanding.
- The original TRC ID tag must not be removed from the unit being claimed for warranty.

- This warranty does not extend to repairs for noise (including idle rattle).
- This warranty only covers the cost of the exact make, model and specifications of the unit that is being claimed for warranty.
- Notwithstanding anything to the contrary, coverage for defects in the input and/or output seals are limited to 30 days from the date of purchase.
- This warranty shall not extend to unit failures, damage or abuse attributed to or caused by (the determination of which is in TRC's sole judgment and discretion): Improper installation or maintenance;
 - · Lack of, low, wrong or contaminated lubricant;
 - Shock load / spin out failures;
 - Broken synchronizer pins;
 - Misadjusted or malfunctioning control modules such as transmission control modules, sensors, cables, clutches, shifters etc.;
 - Operation in excess of original design limitations, including overloading, shock loading or spin out;
 - Failure to follow normal published preventive maintenance guidelines of the O.E.M.;
 - Excessive operating temperature or seal leakages;
 - Excessive vibration from engine, clutch or drivelines, including transmission synchronizer pin breakage and improper driveline angles;
 - Failure to perform proper cleaning and flushing as per guidelines published by the O.E.M.; and
 - Ancillary equipment such as PTO's, yokes, speedometer, oil cooler and clutch release parts.
- This warranty does not cover failures caused by a worn, damaged or defective part or component mounted to the unit by the dealer or retail purchaser, including without limitation, the transmission end yoke.
- If requested by TRC, the component or assembly involved shall be returned via prepaid freight to a TRC service center and must be received by TRC within 45 days of receiving the TRC authorization number.
- Labor charges, where applicable will be limited to the flat rate labor rates defined by TRC.
- TRC shall not pay for any outside repair, labor charges, towing charges, loss of time charges or any other charges unless authorized in advance by TRC.

THIS LIMITED WARRANTY SHALL BE THE SOLE AND EXCLUSIVE REMEDY AGAINST TRC AND UNDER NO CIRCUMSTANCES SHALL TRC BE LIABLE FOR AN AMOUNT GREATER THAN THE ACTUAL PURCHASE PRICE OF THE APPLICABLE UNIT OR UNITS OR ANY CONSEQUENTIAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES. TRC SHALL NOT BE BOUND BY ANY REPRESENTATIONS, WARRANTIES OR INDEMNITIES MADE BY ANY OTHER PERSON WHICH ARE INCONSISTENT WITH THIS LIMITED WARRANTY. TRC SHALL NOT BE LIABLE FOR ANY DAMAGES WHICH ARE BASED UPON NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF WARRANTY, BREACH OF CONTRACT, STRICT LIABILITY OR ANY OTHER LEGAL THEORY OF LIABILITY OTHER THAN THE EXCLUSIVE LIABILITY SET FORTH IN THIS LIMITED WARRANTY.

THIS WARRANTY SHALL EXTEND TO THE ORIGINAL PURCHASER ONLY, IS IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, AND ALL SUCH WARRANTIES AND INDEMNITIES ARE EXPRESSLY DISCLAIMED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND OF MERCHANTABILITY.
